## **I – PARTICULAR CONDITIONS**

### **1 – OBJECT OF THE CONTRACT**

Sale of ONE (1) used vehicle, in its current condition, owned by the Embassy of the Argentine Republic in South Africa, in accordance with these Particular Conditions and Technical Specifications.

### **2 – INQUIRIES REGARDING THE TERMS AND CONDITIONS**

Any inquiries regarding these Terms and Conditions must be submitted in writing to the Embassy, located at 440 Hilda Street, Standard Plaza building, 2nd floor, Hatfield, Pretoria, or via the institutional email address [esafr@mrecic.gov.ar](mailto:esafr@mrecic.gov.ar), up to FIVE (5) business days prior to the date scheduled for the opening of bids. Inquiries must be submitted in Spanish or English.

At the time of submitting an inquiry, those who have not previously done so must provide their name or company name, address, and email address, which will be considered valid for all communications until the bid opening date. Telephone inquiries will not be accepted, nor will inquiries submitted after the deadline be answered.

Clarifying or amending circulars may be issued ex officio or in response to inquiries. Such circulars shall form an integral part of these Terms and Conditions and will be published on the Embassy's website: <https://esafr.cancilleria.gob.ar/>.

### **3 – NOTIFICATIONS**

All notifications between the Embassy and interested parties, bidders, awardees, and/or contracting parties may validly be made by any of the following means:

- a) In person
- b) By email
- c) By other means enabled by postal service providers

### **4 – FORM OF SUBMISSION OF BIDS**

Bids must be submitted in hard copy, in sealed envelopes, at the Embassy located at 440 Hilda Street, Standard Plaza building, 2nd floor, Hatfield, Pretoria, by the date and time established for the receipt of envelopes.

If, prior to the submission deadline, a bidder wishes to correct, supplement, or replace a bid already submitted, the last bid submitted within the deadline shall be considered valid.

The mere submission of a bid implies full knowledge and acceptance by the bidder of the clauses governing this procedure and their exact scope.

### **5 – CONTENT OF THE BID**

Bids must comply, at a minimum, with the following requirements:

- 5.1. The bid must be drafted in Spanish or English.
- 5.2. Any erasures, amendments, corrections, or interlineations must be duly initialed by the signatory of the bid.
- 5.3. The bid must be signed on each and every page by the bidder or their legal representative.
- 5.4. The envelopes, boxes, or packages containing the bids must be properly sealed and must state on the outside the following information:

**5.5. The bid must include the following information:**

- Full name or company name, address, telephone, fax, and email address of the bidder, where all notifications shall be deemed valid.
- Establishment of a special address in the city of Pretoria.

**5.6. If the bid is signed and submitted by a legal representative, a copy of the power of attorney or documentation evidencing such representation must be attached.**

**5.7. ECONOMIC OFFER:**

The economic offer must be submitted as part of the proposal using the QUOTATION FORM Annex, indicating the price in numbers and words, with reference to the established unit and the total bid amount.

If the total quoted does not correspond to the unit price, the latter shall prevail.

The economic offer must be signed by the bidder or their legal representative and must be expressed in South African Rand (ZAR).

Offers may not be lower than the BASE PRICE stated in the QUOTATION FORM Annex.

It shall be understood that, prior to submitting the bid, the bidder has ensured that the quoted price covers all obligations arising from the contract, including all services necessary for full and proper performance, even if not explicitly stated in the bid.

**6 – VEHICLE INSPECTION – DEFECTS**

The vehicle offered by the Embassy will be available for inspection at the place and until the date and time indicated on the cover page of these Terms and Conditions.

Bidders acknowledge that they have had the opportunity to inspect the asset and that if they decide to submit bids without having carried out such inspection, they do so at their own risk, and therefore may not make any claims regarding defects in the awarded asset.

Bidders irrevocably waive the right to invoke warranty claims for hidden defects in relation to the assets subject to this contract.

## **7 – AUCTION PROCEEDINGS**

On the indicated date and time, bids will be opened in a public act, in the presence of the designated officials and any interested parties who wish to attend. A record of the act shall be drawn up and signed by the participating officials and any bidders or interested parties present who wish to do so.

If the scheduled bid opening date is declared a non-working day, the act shall take place on the next business day, at the same place and time.

No bid submitted within the deadline may be rejected at the opening ceremony. Any observations shall be recorded in the opening minutes for subsequent analysis by the competent authority.

## **8 – ORAL BIDDING**

TWO (2) business days after the auction date, at the established time, admissible bids will be read aloud.

Upon completion, bidders will be invited to improve their offers through oral bidding, with the award granted to the highest bid.

The results of the auction shall be recorded in minutes, which shall be signed by the participating officials and any bidders present who wish to do so.

## **9 – VEHICLE EXPENSES**

All transportation, freight, handling, loading, and any other costs required for the fulfillment of the contract shall be borne exclusively by the highest bidder. The bidder shall also bear all applicable taxes, customs duties, clearance costs, and any other charges affecting the acquired asset.

All vehicle transfer expenses shall be included in the offered price and borne exclusively by the contracting party. The Embassy shall provide the necessary documentation for the transfer process within the deadlines established herein.

## **10 – FINES**

At the time of delivery, the vehicle offered by the Embassy shall be free of fines. The Embassy shall be responsible for the settlement of any fines incurred prior to the issuance of the SALES ORDER.

## **11 – DAMAGES**

Once acquired and removed, the buyer shall be solely responsible for any damage or harm caused to third parties, including all related costs.

## **12 – MAINTENANCE OF THE BID**

Bidders shall be required to maintain their offers for FIFTEEN (15) calendar days from the bid opening date.

This period shall be automatically extended for equal successive periods unless the bidder expressly states their intention not to renew, with at least TEN (10) calendar days' notice prior to the expiration of each period.

## **13 – AWARD**

The award shall be granted to the offer that complies with all requirements and is deemed most advantageous, considering quality, bidder suitability, and the highest price offered.

The award decision shall be notified to the successful bidder and all other bidders within THREE (3) business days, by any of the notification methods provided herein.

Within TEN (10) business days of notification, the SALES ORDER shall be issued and notified to the awardee.

## **14 – DELIVERY DEADLINE AND METHOD**

Upon receipt of the SALES ORDER, the awardee must contact Mr. Fabián Sáez or assistant Ms. Lina Giménez, representatives of the Embassy, to carry out the procedures required for vehicle ownership transfer.

Once the transfer is completed, the awardee shall have a maximum of FIFTEEN (15) business days to collect the used vehicle, which shall be delivered in full and in its current condition.

All movement, loading, and transportation shall be at the awardee's sole risk and expense.

## **15 – PLACE OF DELIVERY**

The contracting party shall be obliged to collect the vehicle from the Embassy of the Argentine Republic in the city of Pretoria.

## **16 – PAYMENT METHOD**

Payment shall be made upon delivery of the vehicle and upon presentation of the corresponding proof of payment.

## **17 – PENALTIES**

Failure to comply with the deadlines established herein shall result in a penalty of ZERO POINT ZERO FIVE PERCENT (0.05%) of the amount paid late.

## **18 – TERMINATION OF THE CONTRACT**

If the awardee expressly withdraws from the contract before the deadline for performance, or fails to comply after the original deadline, any extension, or any formal notices, the Embassy shall declare the contract terminated without the need for judicial or extrajudicial notice, unless it chooses to accept late performance.

## **19 – LIABILITY**

The contracting party shall comply with all applicable legal regulations and shall be responsible for all extrajudicial and judicial claims, including costs and expenses, arising from its acts or omissions, or those of its personnel, subcontractors, or other persons for whom it is responsible.




The overall condition is regular. It presents minor dents, torn upholstery on the driver's seat, and malfunctioning gear box.
